

General terms and conditions Motorhome parking space Malbun of the municipality of Triesenberg

1. Scope of application and ownership

The terms and conditions apply to all reservation requests and reservations for the Malbun motorhome pitches of the municipality of Triesenberg. The municipality of Triesenberg is the owner of the land on which the pitches are located.

2. Bookings and confirmations

Bookings for the pitches in Malbun can only be made via tourismus.li/wohnmobilstellplatz. The prices and availability stated on the website apply. Reservations must be made by a person of legal age. Reservations for third parties are not permitted. You will receive the booking confirmation directly from tourismus.li. When making the reservation, the tenant confirms that they have read the General Terms and Conditions (GTCs) and accept them.

3. Guest accommodation contract and payment

The guest accommodation contract is concluded directly and exclusively between the person making the booking (guest) and Wohnmobil-Stellplatz Malbun of the municipality of Triesenberg after a pitch has been booked. The price confirmed by Wohnmobil-Stellplatz Malbun der Gemeinde Triesenberg (or via tourismus.li/wohnmobilstellpatz) must be paid by credit card when booking online in order to finalize the booking.

4. Changes

The municipality of Triesenberg reserves the right to make changes to the GTCs and parking space regulations for the parking spaces. Any changes will be continuously updated in the reservation system. The current GTCs as well as the information and regulations in the online reservation system, which are also sent with the booking confirmation, are binding.

5. Payment options

The Malbun motorhome pitches in the municipality of Triesenberg can be booked and paid for online at tourismus.li/wohnmobilstellpatz or at the Malbun Center - Tourist Office (Im Malbun 3, 9497 Triesenberg) daily from 09:00 to 17:00. Guests can pay for pitch reservations in cash or by credit card on site or online by credit card.

6. Cancellation costs for motorhome pitches

The guest is obliged to notify all changes to the contract directly and as early as possible. Cancellation of the reservation is free of charge up to 10 days before arrival. In the event of cancellation within 10 days prior to arrival, the total amount is due. We recommend that you take out cancellation insurance.



7. Arrival and departure

Arrival is possible from 4pm on the day of arrival. The pitch may also be available earlier if the pitch has not been reserved the day before. Departure must take place by 12am on the day of departure. We ask our guests to leave on time so that the next guests can arrive on time.

8. Self-check-in

You can check in in person at the parking space using the QR code shown on the check-in board. You will need a smartphone or tablet with internet access and a camera. The staff at the Malbun Center - Tourist Office will be happy to answer any questions you may have.

9. Parking space regulations

By making a reservation, guests agree to the GTCs and the parking space regulations (page 3). Violation of the parking space regulations can lead to immediate expulsion.

10. Data protection

For the Malbun motorhome pitches in the municipality of Triesenberg, the protection of privacy has absolute priority. We endeavor to guarantee our guests the highest level of data protection and security. The personal details collected during the booking process are stored and used exclusively for the correct processing of the reservation, booking and stay on the pitch. We also use this data anonymously for statistical and analytical purposes.

Parking Space Ordinance

Motorhome parking space Malbun in the municipality of Triesenberg.

- 1. There are a total of 12 parking spaces on the P2 parking lot in Malbun.
- 2. Arrival is permitted from 4pm. Departure must take place by 12am.
- 3. Pitch size: 8m long x 5m wide. Larger motorhomes are requested to use the "Mittagsspitze" campsite in Triesen.
- 4. Caravans and tents are not permitted.
- 5. Please observe the existing parking markings.
- 6. The fee per night and pitch: CHF 15.00.- (excl. visitor's tax)
- 7. Electricity can be obtained from the existing columns. Costs: CHF 0.35 per kWh. Generators are prohibited.
- 8. Absolute night rest applies from 10pm to 7am o'clock
- 9. Gas barbecue, awning, table and chairs are permitted. However, these must be put away when leaving the site and at night.
- 10. Open fires are prohibited on the entire site and in the adjacent meadows. There are various public barbecue sites in Triesenberg.
- 11. Toilet cassettes may only be emptied into the drain provided for this purpose (emptying at the combined heat and power plant building next door).
- 12. Toilet facilities are located on the pitch and/or in the Schlucher-Treff restaurant (approx. 200m away). Please do not use the surrounding nature for your business.
- 13. Dishes and clothes may not be washed in the public toilet facilities or the surrounding nature.
- 14. The pitch must always be left clean.
- 15. Dispose of waste in the bins provided. There is a waste disposal point at the Malbun parking garage (garbage bags, glass, cardboard, PET, paper). Tokens for 35 liter garbage bags can be purchased at the Malbun Center or Malbun Sport.
- 16. The operator (municipality of Triesenberg) accepts no liability for damage to property, theft and/or personal injury.
